## REQUEST FOR MONTHLY BILLING OR DIRECT DEBIT

To facilitate payment of your electricity bills, SÉOLIS offers you the direct debit option. You may choose between:

Debit on due date (the amount of your bill is debited from your account 15 days after the date of issuance of the bill)

Monthly direct debit (an instalment plan is sent to you and set up when your acceptance is received)

You choose the date of your debits:  5  10  15  20

If one of these arrangements interests you, please return this document to us with a bank identity statement (RIB).

Next, we will send you an order to sign, authorising SÉOLIS to process debits against your account.

# THE REGULATE BLUE TARIFF

(for supplies 3 to 36 kVA)

The Regulated Electricity Sales Tariff is regulated by the public authorities. It changes according to the sector's costs and is generally revised twice a year, usually in February and August, following the adoption of a decision by the ministers responsible for the economy and energy after consulting the the French Energy Regulatory Commission.

## BASIC OPTION

- The same price, day and night, all year long.
- You choose simplicity.

*Recommended if you use few electrical appliances and you do not pay attention to the power consumption time slots.*

## OFF-PEAK HOURS OPTION

- A lower price for 8 out of 24 hours, called "off-peak hours" \*.
- A subscription price based on the power supply level you have chosen.

*Recommended if you use a lot of electrical appliances, such as electric heating or an electric water heater.*

\* Off-Peak Hours period according to the on-site meter settings, not modifiable.

## TEMPO OPTION

- A price that varies based on the time of year.
- During the year: 300 days at low price (blue), 43 days at average price (white) and 22 days at high price (red).
- These days are specified on the Tempo calendar, which may be viewed at [www.seolis.net](http://www.seolis.net) and on the Tempo unit installed in your home.
- The 22 red days are spread out between 1st November and 31st March; they may be consecutive or non-consecutive. Red days are never on Saturdays, Sundays or bank holidays.
- Regardless of the colour, you will have off-peak hours from 10 pm to 6 am.

*Recommended if you have an energy source other than electricity for your heating, such as a stove or a fireplace insert, to use during red periods.*
